CERTIFICATE OF INCORPORATION
OF
R. & H. CONSTRUCTION COMPANY

This is to certify that we, the undersigned, do hereby associate ourselves into a corporation under and by virtue of the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes, entitled "Corporations," and the several amendments thereto, and do severally agree to take the number of shares of capital stock in said corporation set opposite our respective names, and to that end do hereby set forth:

1. The name by which the corporation is designated and to be used in its business dealings is R & H Construction Company.

2. The location of the principal office of the corporation in this state is at Winston-Salem; but it may have one or more branch offices and places of business out of the State of North Carolina, as well as in said state.

3. The objects for which this corporation is formed are:

To take, lease, purchase or otherwise acquire, and to own, use, hold, sell, convey, exchange, lease, mortgage, work, improve, develop, cultivate, and otherwise handle, deal in, and dispose of real estate, real property, and any interest or right therein.
