WITNESSETH:

WHEREAS, the restrictions for the lots in the subdivision of Shattalon Lake Estates, Section No. 1, as recorded in Plat Book 21, Page 23, in the Office of the Register of Deeds of Forsyth County, North Carolina, are recorded in Deed Book 832, Page 354; and

WHEREAS, a portion of restriction number (2) of said recorded restrictions requires that "No residence shall be erected that has less than 1600 square feet of floor space on the ground floor. This is exclusive of garages, porches and breezeways."; and

WHEREAS, the owners of all lots in said subdivision believe it is in the best interest of those owning property in said subdivision to modify said portion of restriction number (2) to read as follows:

No residence shall be erected unless it shall contain at least 1600 square feet of floor space if the structure is a one story building, at least 2000 square feet of floor space if the structure is a split level building, or at least 2400 square feet of floor space if the structure is a two story building. The floor space referred to herein shall be heated and finished living area, shall

be measured from the exterior walls and shall be exclusive of porches, terraces, garages, basements and breezeways. In the case of a split level house any portion of the ground floor which is heated and finished and used as a part of the living area shall not be considered a basement, but at least 1800 square feet of floor space must be above the lower level of the house.

In the case of a split level house any portion of the ground floor which is heated and finished and used as a part of the living area shall not be considered a basement, but at least 1800 square feet of floor space must be above the lower level of the house."
