East 67.70 feet from the south-east corner of that lot described in Deed Book 845, page 367, recorded in the Forsyth County Register of Deeds Office, and running thence along said west right-of-way line of Williams Street South 05 deg. 00 min. East 10.0 feet to a point, the old northwest intersection of Williams Street and Stadium Drive; thence along the old north right-of-way line of Stadium Drive North 85 deg. 00 min. West 200.0 feet to a point, the old northeast intersection of Salem Avenue and Stadium Drive; thence along the old easterly right-of-way line of said Salem Avenue North 05 deg. 00 min. West 77.7 feet to a point; thence South 85 deg. 00 min. East 5.0 feet to a point, a new corner; thence along a line that is 5.0 feet East of and parallel to the old East line of Salem Avenue, said line being the new easterly right-of-way line of Salem Avenue, South 05 deg. 00 min.
