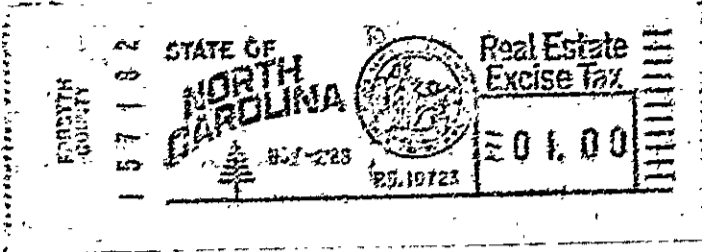

### NORTH CAROLINA GENERAL WARRANTY DEED

THIS DEED made this 31st day of October, 1988, by and between
