AN ORDINANCE DESIGNATING CERTAIN PROPERTY AS A HISTORIC LANDMARK

WHEREAS, all of the prerequisites to the adoption of this ordinance as prescribed by Chapter 160A, Article 19, Part 3C of the North Carolina General Statutes have been met; and

WHEREAS, the <u>Forsyth County Joint Historic Properties</u>
Commission has submitted a report, which is incorporated herein
by reference, and recommends after a separate public hearing that
the property described below be designated a historic landmark;
and

WHEREAS, the Board of Aldermen after a separate public hearing finds that the property described herein is of historical, architectural, and/or cultural significance, and the property's preservation should be encouraged, and that the qualifying elements exist as set forth in the Historic Properties Commission report:

NOW, THEREFORE, BE IT ORDAINED by the Board of Aldermen of Winston-Salem as follows:

<u>Section 1</u>. The following described property is hereby designated a historic landmark:

The Bethabara Distiller's House, interior and exterior of the house, and Tax Block 3459, portion of Lot 5 as shown on the Forsyth County Tax Maps.

<u>Section 2</u>. The waiting period provided by law shall be observed prior to demolition, alteration, remodeling, or removal of the designated property.


<u>Section 3</u>. This ordinance shall be effective from and after its adoption.
