This Modification of Building Line and Covenant Not to Sue made this the 19th day of July, 1973, by ROGER D. JONES and wife, EMILY K. JONES, J. RAY WOODRUFF (Single), L & H LAND COMPANY, THE FIDELITY COMPANY, PIEDMONT FEDERAL SAVINGS AND LOAN ASSOCIATION, parties of the first part to JOHN H. WHITEHEART and wife, BETTY JO WHITEHEART, parties of the second part.

WITNESSETH:

WHEREAS, ROGER D. JONES and wife, EMILY K. JONES, are the owners of Lot 6 as shown on the plat of Carroll Estates recorded in Plat Book 24, page 102 in the Office of the Register of Deeds of Forsyth County, North Carolina.

WHEREAS, THE FIDELITY COMPANY is Trustee in a deed of trust to Piedmont Federal Savings and Loan Association covering Lot 6 recorded in Deed of Trust Book 1080, page 505, Forsyth County Registry.


