MEMORANDUM OF LEASE

PARKVIEW MALL, a Joint Venture consisting of K & H INVESTMENT COMPANY, a partnership having its principal office in Richmond, Virginia, and RCS, INC., a North Carolina corporation having its principal office in Winston-Salem, North Carolina, hereby leases to PIEDMONT FEDERAL SAVINGS AND LOAN ASSOCIATION, a Federal Savings and Loan Association, a United States Corporation, with its principal office in the City of Winston-Salem, Forsyth County, North Carolina, for a term beginning on or before the 1st day of November, 1975, and ending on or before the 31st day of October, 2005, including all options to extend or renew, if any, the following property lying and being in Forsyth County, North Carolina, and more particularly described as follows:

BEGINNING at a point in the east right-of-way line of Reynolds Park Road, said point being marked by an iron stake at the northwest corner of the tract or parcel conveyed to First Federal Savings and Loan Association by RCS, Inc., and being located Northwardly 149.96 feet from an iron at the northeast corner of the Waughtown Street and Reynolds Park Road intersection; thence with the East line of Reynolds Park Road North 04 degrees 05 minutes 05 seconds West 120.0 feet to an iron stake; thence North 85 degrees 59 minutes 55 seconds East 120.0 feet to an iron stake; thence South 04 degrees 05 minutes 05 seconds West 120.0 feet to an iron stake in the north line of First Federal Savings and Loan Association property; thence with said line South 85 degrees 59 minutes 55 seconds West 120.0 feet to the point and place of BEGINNING.

The above-described property is subject to that portion of a 50-foot utility easement running to the benefit of the City of Winston-Salem on which the northeast corner of the above-described land encroaches. The aforesaid utility easement was reserved by the City of Winston-Salem in their former right-of-way line of Reynolds Park Road which was closed by action of the Board of Aldermen.
