AN ORDINANCE ORDERING THE SUPERINTENDENT OF INSPECTIONS OF THE CITY OF WINSTON-SALEM TO REMOVE OR DEMOLISH HOUSING UNFIT FOR HUMAN HABITATION AND, OTHERWISE, TO EFFECTUATE THE PURPOSE OF CHAPTER 5, ARTICLE IV OF THE WINSTON-SALEM CITY CODE.

WHEREAS, the Superintendent of Inspections, after due notice and hearing, has determined that the property hereinafter described is unfit for human habitation and that the owner thereof has failed to repair the same so as to bring it into compliance with the Housing Code of the City within the time granted in an order issued by the Superintendent of Inspections;

NOW, THEREFORE, BE IT ORDAINED by the Board of Aldermen of the City of Winston-Salem, as follows:

Section 1. The Superintendent of Inspections of the City of Winston-Salem is hereby ordered to proceed to effectuate the purpose of the Housing Code of the City of Winston-Salem (Chapter 5, Article IV of the Code of the City of Winston-Salem) with respect to the property hereinafter described, which the Superintendent of Inspections has heretofore found to be unfit for human habitation. The Superintendent shall cause all housing on said property heretofore found by him to be unfit for human habitation to be removed or demolished, and he is hereby authorized and directed to take such other action and to exercise such other powers with respect to said property as may be necessary or convenient to carry out and effectuate the provisions of the Housing Code of the City of Winston-Salem.
