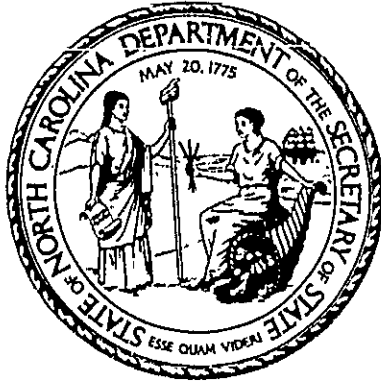

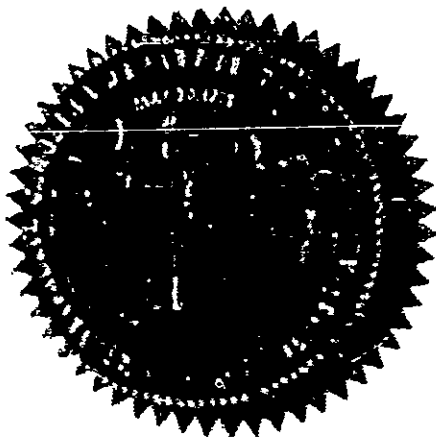

ARTICLES OF INCORPORATION
H. & H. EURE

I, the undersigned natural person of the age of eighteen (18) years or more, do hereby incorporate a business corporation under the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act," and the several amendments thereto, and to that end do hereby set forth:

1. The name of the Corporation is "H. & H. Cartage Co., Inc."

2. The period of duration of the corporation shall be perpetual.

3. This corporation's purpose is to engage for profit in the general business of transporting cargo, of various kinds, for other companies and individuals, over the road, by truck and/or vehicular means.

4. The aggregate number of shares which the corporation shall have authority to issue is 1000 with no par value.

5. The minimum amount of consideration for its shares to be received by the corporation before it shall commence business is \$100.00.

6. The address of the initial registered office of the corporation is 403 Pepper Building, Winston-Salem, Forsyth Co. North Carolina, and the name of the initial registered agent at such address is H. Glenn Pettyjohn.

7. The number of directors of the corporation may be fixed by the by-laws, but shall not be less than three.

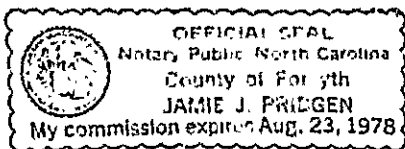
