WHEREAS, it is the desire of the parties hereto who are the developers and owners of all the lots in said development together with their lien holders, to amend and modify the building set back lines as shown on the recorded plat and to amend and modify the restrictions heretofore imposed.

NOW THEREFORE, the parties hereto in consideration of the sum of \$1.00 paid to each other, the receipt of which is hereby acknowledged, and in further consideration of the covenants herein contained, do hereby mutually agree as follows:

That the restrictions contained in Deed Book 1014, page 366, in the Office of the Register of Deeds, Forsyth County, North Carolina, concerning CARROLL ESTATES, together with the building set back lines as shown on the plat of CARROLL ESTATES, recorded in Plat Book 24, page 102, same registry, are hereby deleted in their entirety and in the place of same the following restrictions and building set back lines are imposed:

1. All lots shown on the recorded plat shall be used for residential

purposes only and no building shall be erected, placed or permitted to remain on any lot other than one detached single family residence and customary accessory buildings used in connection therewith for customary uses.

2. The lots as shown on the recorded plat may be sub-divided, however, each building lot shall contain not less than 20,000 square feet of area and shall have at least 100 feet of road frontage. This restriction shall not preclude the building of single family dwellings on lots 1A, 1B, 1C and 1, so long as they have at least 90 feet of road frontage, on Lots 25, and 32, as shown on the recorded plat with 43.97 and 46.12 feet of road frontage respectively, and Lots 26 and 31, may be sub-divided with the southern part of each having road frontage of not less than 40 feet each.

3. No single family dwelling shall be built, erected or used unless it shall contain at least 1200 square feet of floor space if the structure is a one-story building or at least 1800 square feet of floor space if the building shall be a two-story dwelling, split-level dwellings shall contain at least 1200 square feet of floor space on the two main levels of the dwelling. The floor space herein referred to shall be exclusive of porches, garages, breezeways, terraces and basement areas.

4. No building or part of a building other than steps, open porches, overhanging eaves or cornices shall extend nearer the front property line than 40 feet except buildings constructed on Lot # 22 or part thereof shall set back at least 50 feet from the front property line. In the case of a corner lot any building may be placed within 20 feet of the side street property line. The rear yard shall have a depth of not less than 35 feet, except a detached private garage may be placed within 10 feet of the rear property line.

5. Every building erected on the properties shown on the plat shall have two side yards with a total footage of not less than 25 feet and in no case shall the width of either side yard be less than 10 feet.

6. No swine, chickens, fowl or other livestock shall be kept on the premises. Household pets may be kept for non-commercial purposes if they are properly confined and do not constitute a nuisance.

7. No portion of any building erected on this property shall have exposed concrete blocks on the exterior.

8. No building may be moved from another location and placed on any lot in this sub-division. It being specifically required that any dwelling house built or placed in this sub-division shall be of new construction and constructed on the premises. Mobile Homes are specifically prohibited.

9. No structure of a temporary character, trailer, basement, tent, shack, garage, barn, or other out buildings shall be used on any lot at any time as a residence either temporarily or permanently.

10. Any restriction dealing with set back lines and side yard requirements hereinbefore set forth may be removed, modified or changed by securing the written consent of the adjoining building lot owner or owners of the building lot in question. In the event the adjoining property is owned by the party seeking to remove,

modify or change the same, then, in that event the next adjoining building lot owner different from the party seeking modification on the same side of the street shall consent to the removal, modification or change. In no event shall this paragraph confer any rights to property owners not within the development. In the event there is no property owner different from the party desiring modification on the same side of the street, then in that event, the property owner directly in front of the structure built or to be built shall consent to such modification. Such written consent shall be duly executed, acknowledged and recorded in the Office of the Register of Deeds of Forsyth County, North Carolina, and which consent may be given or withheld within the uncontrolled discretion of said adjoining building lot owner or owners.

11. It is agreed that any dwelling now constructed in Carroll Estates which may violate the restrictions herein imposed, concerning square footage requirements or locations of same on the property, may remain and shall not be in violation of the restrictions herein imposed.
