

ARTICLES OF INCORPORATION

OF

R & R ATHLETIC EQUIPMENT, INC.

We, the undersigned, being persons of full age, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina.

I.

The name of the corporation shall be "R & R Athletic Equipment, Inc.".

II.

The period of duration of the corporation shall be perpetual.

III.

The objects for which this corporation is created are as follows:

A. To engage in business as jobbers and retailers of hardware of all kinds and descriptions; to buy, sell, export, import and generally deal in railway, steamboat, manufacturers', mill, plumbers', miners', blacksmiths', steam fitters', and gas fitters' supplies; and to buy, sell, export, import and generally deal in sheet iron, tools, cutlery, saddlery, and saddlers' goods, round and bar iron, bar and tool steel, guns and sporting goods of all kinds and descriptions.

B. To engage in any other lawful activity for profit.

IV.

The corporation shall have authority to issue 10,000 shares of common stock at a par value of \$10.00 per share.

v.

The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is \$100.00 in cash or property of equivalent value.

VI.

The shareholders of the corporation shall have the preemptive right to acquire additional unissued shares of the corporation.

VII.

The address of the initial registered office of the corporation is 4205 Rayfield Drive, Winston-Salem, North Carolina 27107, and the name of the initial registered agent at such address is Don C. Rayfield. (Foregraphy County)
