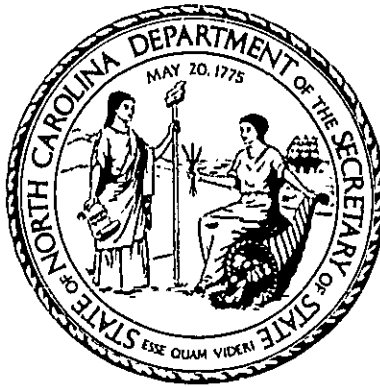

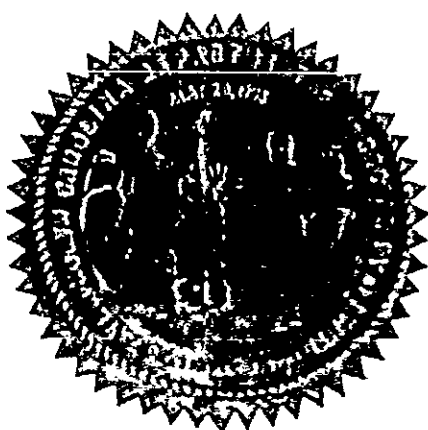

The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge the Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina:

1. The name of the corporation is D & M Dental Laboratories, Inc.

2. The period of duration of the corporation is perpetual.

3. The purposes for which the corporation is organized are:

(1) to engage in the manufacture and sale of restorations and dentures;

(2) to engage in any lawful act or activity for which a corporation may be organized under Chapter 53 of the General Statutes of North Carolina.

4. The corporation shall have the authority to issue one hundred thousand (100,000) shares of stock par value.

5. The minimum amount of contribution to be received by the corporation for its shares before it shall commence business is \$1.00 in cash or property of equivalent value.
