ARTICLES OF INCORPORATION

years or more, does hereby establish a business corporation under the laws of the State of North Carolina as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act," and the several amendments thereto, and to that end does hereby set forth:

- The name of the Corporation is L. & R. Custom Builders, Inc.
- The period of duration of the Corporation shall be perpetual.
- 3. The purpose for which the Corporation is organized is to engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.
- 4. The aggregate number of shares which the Corporation shall have authority to issue is 100,000 all of one class having a par value of \$1.00 per share.
- The minimum amount of consideration for its shares to be received by the Corporation before it shall commence business is \$300.00.
