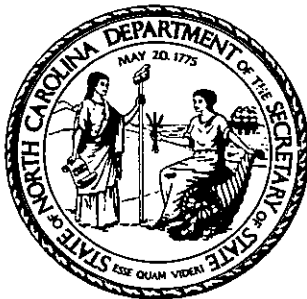

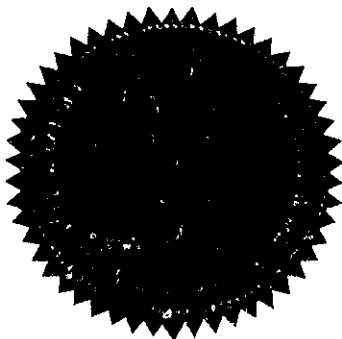

ARTICLES OF INCORPORATION

L. & R. CUSTOM BUILDERS, INC.

The undersigned natural person of the age of eighteen years or more, does hereby establish a business corporation under the laws of the State of North Carolina as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act," and the several amendments thereto, and to that end does hereby set forth:

1. The name of the Corporation is L. & R. Custom Builders, Inc.

2. The period of duration of the Corporation shall be perpetual.

3. The purpose for which the Corporation is organized is to engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.

4. The aggregate number of shares which the Corporation shall have authority to issue is 100,000 all of one class having a par value of \$1.00 per share.

5. The minimum amount of consideration for its shares to be received by the Corporation before it shall commence business is \$300.00.

6. The address of the initial registered office of the Corporation is P.O. Box 1113, Kernersville, Forsyth County, N. C., and the name of the initial registered agent at such address is John E. Largen, III.

7. The number of directors of the Corporation may be fixed by the Bylaws, but in no event shall the number be less than the minimum required by law;

The number of directors constituting the initial Board of Directors shall be two and the names and addresses of the individuals who are to serve as directors until the first meeting of shareholders or until their successors are elected and qualified are:

8. The name and address of the incorporator is: John E. Largen, III., 1333 Amylee Trail, Kernersville, N. C. 27284.

9. In addition to the general powers granted Corporations under the laws of the State of North Carolina, the Corporation shall have full power and authority to do and perform all acts not specifically prohibited by law and which could be performed if recited verbatim in the Chapter.
