

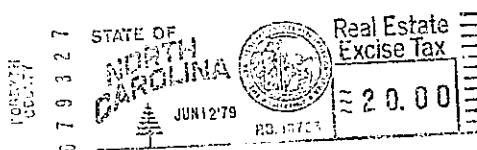

EXHIBIT "A"

TRACT I

BEGINNING at a point on the north side of Vargrave Street (formerly Banks Street) at the northwest intersection of Deane Street (formerly Forsyth Street) and Vargrave Street; running thence along the north side of Vargrave Street West 150 feet to a point in the southeast corner of Lot No. 26; thence along a part of the east line of Lot No. 26 North 50 feet to a point in the southwest corner of Lot No. 28; thence along the south line of Lot No. 28 East 150 feet to a point on the west side of Deane Street; thence along the west side of Deane Street South 50 feet to the place of BEGINNING, being Lot No. Twenty-Nine (29) as shown on map of Powder House Field, which map is not on record in the office of the Register of Deeds of Forsyth County, North Carolina, but is on file in the office of the Moravian Church in Salem.

TRACT II

BEGINNING at an iron stake in the North line of Stadium Drive (formerly Bank or Vargrave Street) in the West line of Lot No. 29 on the map hereinafter referred to and running thence Westwardly with the North line of Stadium Drive 50 feet to an iron stake in the East line of Lot No. 25; thence Northwardly with the East line of Lot No. 25, 142.5 feet to an iron stake in the South line of an alley; thence Eastwardly with the South line of said alley 50 feet to an iron stake in the Northwest corner of Lot No. 27; thence Southwardly with the West lines of Lots No. 27, 28, and 29, 144 feet to the place of BEGINNING, being practically all of Lot No. Twenty-Six (26) with the exception of a small strip taken off of the front end of said lot for the purpose of side walk and/or street widening, and this Lot No. Twenty-Six (26) is shown on the map of Powder House Field, which map is not now and has never been filed in the office of the Register of Deeds of Forsyth County, North Carolina, but lies among the papers of the Moravian Brethren at their church office. This lot is known as Lot 26, Block 510 on the City and Forsyth County Tax Map and is all the property purchased by Randell Winebarger and W. C. Gant from B. H. Hughes and wife, Beatrice Hughes, by deed dated June 20, 1952, recorded in Book 654, page 473 in the office of the Register of Deeds of Forsyth County, North Carolina.

TRACT III

BEGINNING at a point on the West side of Deane Street (formerly Forsyth Street) at the Northeast corner of Lot No. 29; thence running West along the North line of Lot No. 29, 150 feet to a point in the East line of Lot No. 26; thence along a part of the East line of Lot No. 26, North 50 feet to a point, the Southwest corner of Lot No. 27; thence along the South line of Lot No. 27 East 150 feet to a point on the West side of Deane Street; thence along the West line of Deane Street South 50 feet to the place of BEGINNING, being Lot No. Twenty-Eight (28) as shown on map of Powder House Field, plat of said property is not recorded in the office of the Register of Deeds of Forsyth County, North Carolina, but is on file in the office of the Moravian Church, Winston-Salem, North Carolina. This is the same property purchased by W. L. Carter from the Moravian Church by deed dated November 3, 1917, recorded in Book 156, page 208, and later conveyed by W. L. Carter to Emma D. Carter by deed dated March 2, 1951, recorded in Book 235, page 12 in the office of the Register of Deeds of Forsyth County, North Carolina.

TRACE IV

Lying and being in the City of Winston-Salem, North Carolina and fronting fifty feet on the south side of Garnet Street and of that width extending back southwardly one hundred and fifty (150) feet to an alley and being known and designated as Lot No. 14 on the plat of the Powder House Field, which is on file in the Office of Salem Congregation, Winston-Salem, North Carolina.

Said lot being further described as having its Northeast corner located 200 feet, more or less, from the Southwest intersection of Garnet and Dean Streets and 223.3 feet, more or less, from the Southeast intersection of Garnet and Williams Street.

TRACT V

BEGINNING at a stake in the Northeast intersection of Stadium Drive (formerly Vargrave Street) and Williams Street; thence running North 6 degrees 10 minutes West 90 feet to a stake in the East line of Williams Street; thence running North 83 degrees 50 minutes East 170.3 feet to a stake; thence running South 6 degrees 00 minutes East 90 feet to a stake in the North line of Stadium Drive (formerly Vargrave Street); thence running South 83 degrees 50 minutes West 169 feet along the North line of Stadium Drive (formerly Vargrave Street) to the place of beginning.

TRACT VI

BEGINNING at a point on the north side of Stadium Drive (formerly known as Vargrave Street), said point of beginning being 169 feet east from the northeast intersection of Stadium Drive and Williams Street and the southeast corner of Lot 22 as shown on the map hereinafter referred to; running thence North along the east lines of Lots 22, 21, and 20, 140 feet, more or less, to a point on the south side of an alley; thence East 150 feet to a point, the northwest corner of Lot 26; thence along the west line of Lot 26 South 143.9 feet, more or less, to a point on the north side of Stadium Drive; thence along the north side of Stadium Drive West 150 feet to the place of BEGINNING, being known as Lots 23, 24, and 25 as shown on map known as Powder House Field, a plat of said property is on file in the Moravian Church Land Office at Salem, N. C. This Deed is made subject to the reservation for a sanitary sewer easement shown in Deed from City of Winston-Salem, to C. L. Allen, dated December 6, 1951, recorded in Deed Book 665, page 370.

TRACT VII

Beginning at the Southeast intersection of Garnet Street and Williams Street, running thence along the South line of Garnet Street East 123.3 feet to a point; thence South 150 feet to a point on the North side of a 15-foot alley; thence along the North side of said alley West 121.4 feet to a point on the East side of Williams Street; thence along the East side of Williams Street North 150 feet to the place of Beginning. Being Lots 18 and 19 on the Plat of Property of Powder House Field, said plat being on file in the Office of the Congregation of United Brethren of Salem and its vicinity.

TRACT VIII

Beginning at a point on the East side of Williams Street, said point being 165 feet South of the Southeast intersection of Williams Street and Garnet Street, running thence along the South side of an alley East 171 feet to a point in the West line of Lot 23 and thence South 50 feet to a point in the North line of Lot 21; thence West along the North line of Lot 21, 170.3 feet to a point in the East side of Williams Street; thence along the East side of Williams Street North 50 feet to the place of Beginning. Being Lot 20 on Plat of Property of Powder House Field, said plat being on file in the Office of the Congregation of United Brethren of Salem and its vicinity.

TRACT IX

Lying and being in the City of Winston-Salem, North Carolina, fronting on Garnett Street, and being known and designated as Lot 17 on the plat of this locality on file in the Office of the Congregation of United Brethren of Salem and Its Vicinity. For further reference see Deed Book 194, page 37 and Deed Book 1018, page 692, Office of the Register of Deeds of Forsyth County, North Carolina. Also being known as Tax Block 510, Lot 17, Forsyth County Tax Records. See also deed from Robert F. Sprinkle, Jr. and wife, to Piedmont Construction Company recorded in Deed Book 1043, page 526, Office of the Register of Deeds of Forsyth County, North Carolina.

TRACT X

Fronting on Garnet Street 50 feet and of that width extending Southwardly 150 feet to an alley; being bounded on the north by Garnet Street, east by the west lines of Lots 12, 11 and 10, south by said alley; west by Lot No. 14; the herein described and conveyed lot being known and designated as Lot No. 13 on the plat of Powder House Field on file in the office of the Congregation of United Brethren of Salem and its Vicinity.

TRACT XI

Measuring 50 feet on Garnet Street and of that width extending Southwardly 150 feet to an alley; being bounded on the north by Garnet Street, east by Lot No. 14, south by said alley and west by Lot No. 16; the same being known and designated as Lot 15 on the plat of Powder House Field on file in the office of the Congregation of United Brethren of Salem and Its Vicinity.

TRACT XII

Fronting on Garnet Street 50 feet and of that width extending Southwardly 150 feet to an alley; being bounded as follows: on the north by Garnet Street, east by Lot No. 15, south by an alley, west by Lot No. 17. The herein described and conveyed lot being known and designated as Lot 16 on the plat of this locality on file in the office of the Congregation of United Brethren of Salem and Its Vicinity.
