COLLATERAL ASSIGNMENT OF LEASE

NOW, THEREFORE, in consideration of the premises, the sum of One Dollar (\$1.00) by each party to the other paid, the receipt of which is hereby acknowledged, and of other good and valuable consideration, Assignor and Jean B. Galeski hereby agree as follows:

- To secure the said loan of \$63,000.00 made this date by Assignee to Joseph S. Galeski, Jr., and to secure all obligations now existing or which may hereafter arise from Assignor to Assignee, Assignor does, by these presents and for himself, his heirs and assigns, assign and transfer to Assignee all of his right, title and interest in and to the Lease and all other leases or tenancies granted by Assignor while any portion of such loan remains unpaid; it being specifically agreed that in the event that Assignor shall default in payment to Assignee of any indebtedness hereby secured, Assignee is hereby authorized to exercise any and all rights of Assignor under the Lease or any other such lease or tenancy, including the right to notify the Tenant, or any other such lessee or tenant, that all rents and other payments due under the Lease or such other lease or tenancy shall thereafter be paid to Assignee until all indebtedness hereby secured shall have been paid in full.
- This Assignment is for security only, and Assignor shall not be disturbed in his enjoyment of possession of the Property or exercise of his rights under the Lease or any other such lease or tenancy except upon default by Assignor under the terms of the note or deed of trust evidencing the loan of \$63,000.00 or any other instruments evidencing obligations hereby secured.
- Jean B. Galeski is a party hereto solely for the purpose of releasing and she does hereby release to Assignee her inchoate right of dower.
