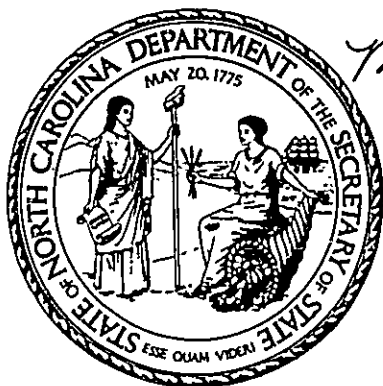

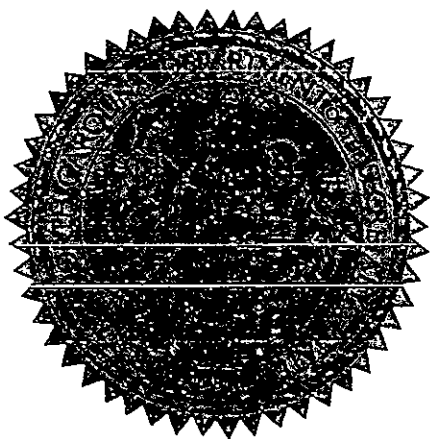

ARTICLES OF INCORPORATION
OF

M & E MACHINE COMPANY, INC.

We, the undersigned natural persons of the age of eighteen years or more, do make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina, and herein set forth the following:

ARTICLE I

The name of the corporation is M & E Machine Company, Inc.

ARTICLE II

The period of duration of the Corporation is perpetual.

ARTICLE III

The purpose for which the Corporation is organized is to engage in any lawful business activity or activities which are authorized by Chapter 55 of the North Carolina General Statutes for Corporations generally.

ARTICLE IV

The minimum amount of consideration to be received by the Corporation for its shares before it shall commence business shall be One Thousand and No/100 (\$1,000.00) Dollars in cash or property of equivalent value. The initial authorized number of outstanding shares shall be 1,000.

ARTICLE V

The address of the initial registered office of the Corporation in the State of North Carolina is 4014 Country Club Road, Winston-Salem, Forsyth County, North Carolina 27104 and the name of its initial registered agent at such address is William L. Durham.

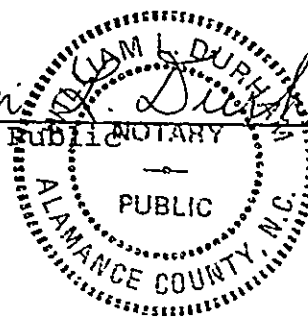
