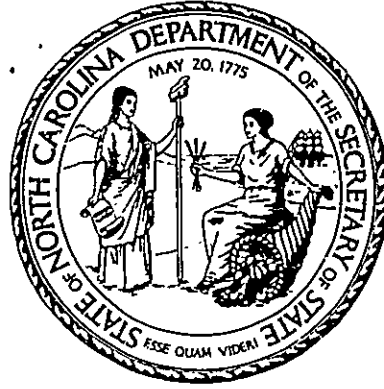

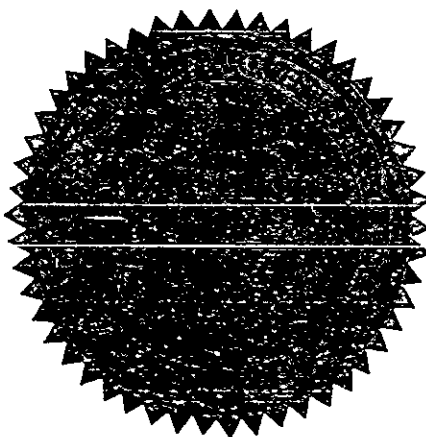

OF

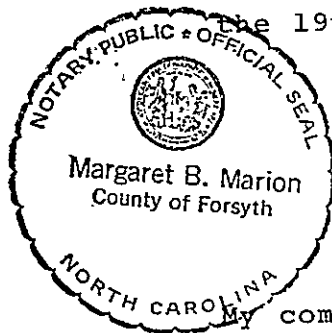
