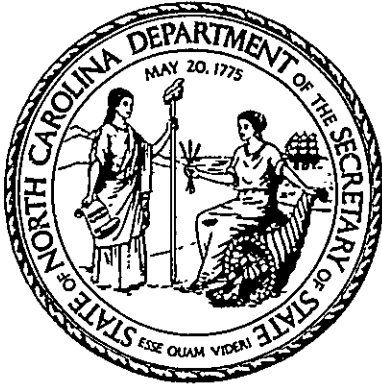

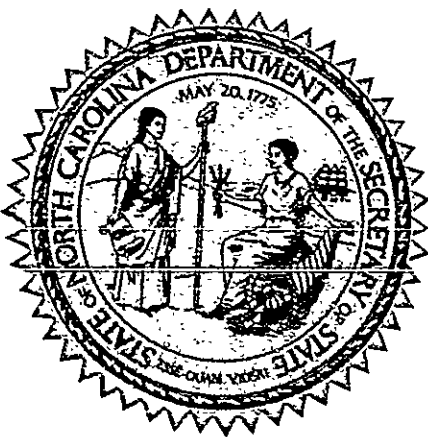



The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act," and the several amendments thereto, and to that end does hereby set forth:

1. The name of the Corporation is D & J GUN SHOP, INC.
2. The period of duration of the Corporation is perpetual.
3. The purposes for which the Corporation is organized are:
 - (a) to engage in the business of operating a firearms and ammunition store, including all activities pertaining thereto; and
 - (b) to engage in any lawful activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.
4. The aggregate number of shares which the Corporation shall have authority to issue is ONE HUNDRED THOUSAND shares with a par value of ONE DOLLAR (\$1.00) per share.
5. The minimum amount of consideration for its shares to be received by the Corporation before it shall commence business is ONE HUNDRED DOLLARS (\$100.00).
6. The shareholders of the Corporation shall have no preemptive right to acquire additional or treasury shares of the Corporation.
7. The address of the initial registered office of the Corporation is 7716 Grapevine Road, Lewisville, Forsyth County, North Carolina, 27023; and the name of its initial registered agent at such address is David Lee Sink.

8. The number of directors constituting the initial board of directors shall be two (2), and the name and address of each person who is to serve as a director until the first meeting of shareholders or until his successor be elected and qualified is:

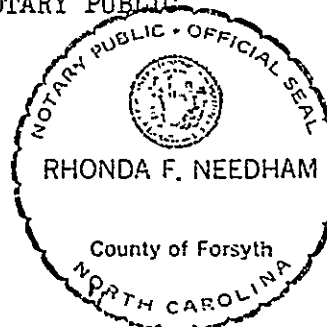
