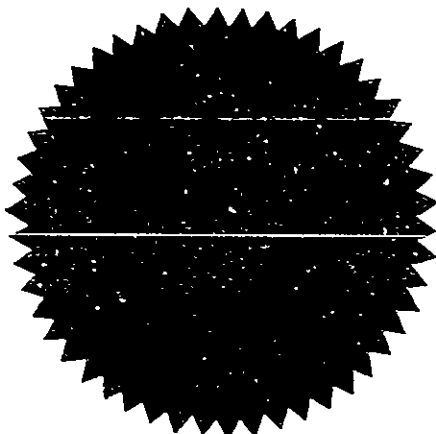

ARTICLES OF INCORPORATION
OF
K & M CONTRACTORS, INC.

The undersigned, being a natural person of the age of eighteen (18) years or more, does hereby execute and acknowledge these Articles of Incorporation pursuant to Chapter 55 of the North Carolina General Statutes for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina:

ARTICLE I.

The name of the corporation is K & M CONTRACTORS, INC.

ARTICLE II.

The period of duration for the corporation shall be perpetual.

ARTICLE III.

The purpose for which the corporation is organized is to engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the North Carolina General Statutes.

ARTICLE IV.

The corporation shall have authority to issue one hundred thousand (100,000) shares of common stock without par value.

ARTICLE V

The minimum amount of consideration for its shares to be received by the corporation before it shall commence business is one dollar (\$1.00) in cash or property of equivalent value.

ARTICLE VI.

The address of the initial registered office of the corporation in the State of North Carolina is 102 S. Cherry Street, Winston-Salem, Forsyth County, North Carolina and the name of its registered agent at such address is Stafford R. Peebles, Jr.

ARTICLE VII.

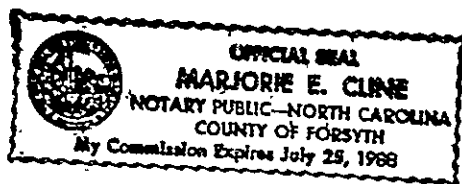
