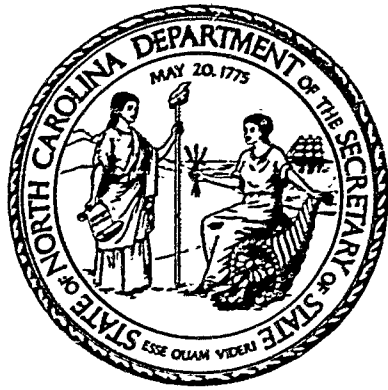

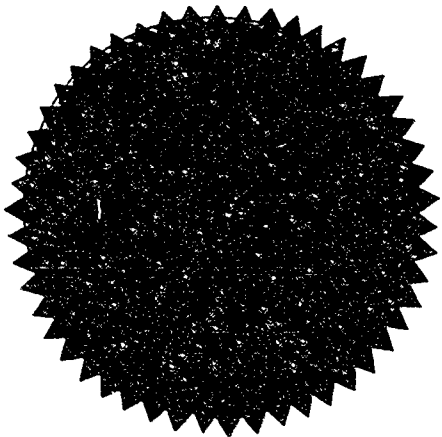

ARTICLES OF INCORPORATION
OF
P & M RESTAURANT CLEANING CORPORATION

I, the undersigned natural person of the age of eighteen (18) years or more, do make and acknowledge these articles of incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina.

1.

The name of the corporation is P & M RESTAURANT CLEANING CORPORATION.

2.

The period of duration of the corporation is perpetual.

3.

The purpose for which the corporation is organized is to engage in any lawful business or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.

4.

The corporation shall have authority to issue One Thousand (1000) shares of common stock at One Hundred Dollars (\$100.00) par value, the total value of said stock shall not exceed One Hundred Thousand Dollars (\$100,000.00).

The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is Four Hundred Dollars (\$400.00), in cash or property of equivalent value.
