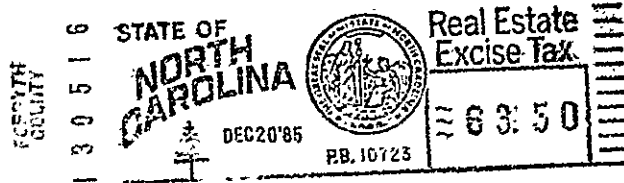

Together with all rights and easements appurtenant to said lot as specifically enumerated in the Declaration of Covenants, Conditions and Restrictions, issued by Koyt Everhart Building Company, Inc., and recorded in Book 1446, at page 1518, in the office of the Register of Deeds of Forsyth County, North Carolina; and membership in Burke Mill Association, Inc.

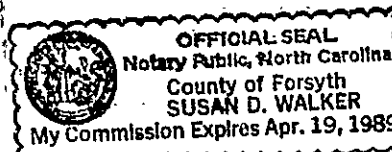
