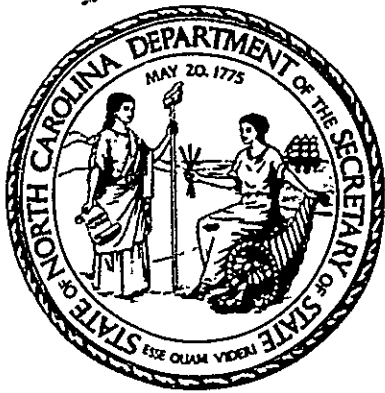

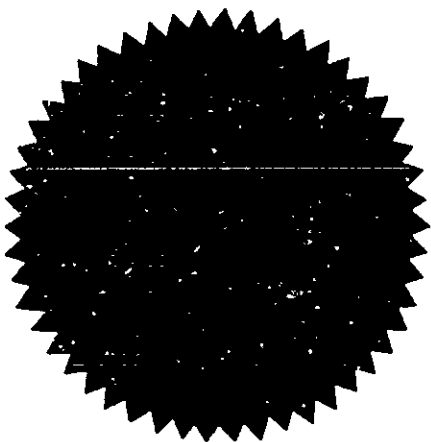

THE UNDERSIGNED, being of the age of eighteen years or more, do hereby make and acknowledge these Articles of Incorporation under the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act," and the several amendments thereto, and to that end do hereby set forth:

I.

The name of the Corporation is C & H ENTERPRISES, INC.

II.

The period of duration of the Corporation shall be perpetual.

III.

The purpose or purposes for which the Corporation is organized are:

- a) To manufacture, buy, sell, repair, import, export and generally deal in all kinds of vehicles, engines, or motor vehicles; and to do and perform all things reasonably necessary or incident thereto.
- b) To equip, maintain, own, lease, operate, and carry on a general machine shop business, cleaning, altering, and overhauling vehicles and to that end buy, sell, install, lease or otherwise deal in any and all articles, implements, apparatus, tools and devices which may be found necessary or convenient in the conduct of such business.
- c) To engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.

IV.

The Corporation shall have authority to issue ten thousand (10,000) shares with a par value of Ten Dollars and No/100 (\$10.00) per share.

V.

The minimum amount of consideration to be received by the Corporation for its shares before it shall commence business is Ten and No/100 Dollars (\$10.00) in cash or property of equivalent value.

VI.

The shareholders of the Corporation shall have no preemptive right to acquire additional or treasury shares of the Corporation.

VII.

The address of the initial registered office of the Corporation is 978 North Liberty Street, Winston-Salem, Forsyth County, North Carolina 27105, and the name of the initial registered agent at such address is CHESTER L. HARRISON.

VIII.



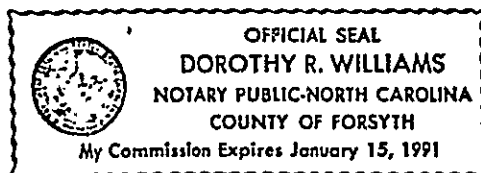
