EXHIBIT B

PROPERTY DESCRIPTION

Being a tract or parcel of land lying in the County of Forsyth and State of North Carolina, and being more particularly described as follows:

BEGINNING at an old iron in the margin of the right-of-way of a state-maintained road, said iron stake being a corner with James Beedings, running thence South 88° 3' East 747.5 feet to an iron stake; thence South 87° 55' East 243.1 feet with the Beedings line and line of William Allgood to a stone, said stone being a corner with William Allgood; running thence South 3° 35' West 836.77 feet with the Allgood line and the line of C.A. Hoots to an iron stake a corner with Hoots and Lonnie Ray Spaugh; running thence North 87° 38' West 134.2 feet to an iron stake, a corner with Lonnie Ray Spaugh and Louise S. Stout; running thence North 2° 22' East 295.7 feet to an iron axle; running thence North 86° 08' West 469.0 feet with the lines of Louise S. Stout, H. Hugh Largen and Donnie Ray Spaugh to an iron stake; running thence South 1° 57' West 6.25 feet more or less to an iron stake; thence North 89° 30' West 100.10 feet to an iron stake; thence North 61° 32' West 130.3 feet to an iron stake; running thence North 15° 22' West 215.0 feet to an iron stake; thence North 15° 22' West 154.07 feet to an iron stake; thence North 15° 22' West 130.93 feet to an iron stake, the point and place of BEGINNING. Containing 11.83 acres, more or less. This description was prepared from an unrecorded survey plat of the property made in March, 1974 by June Lineback, Registered Surveyor. There is excepted from the above tract Lot 2-A also known as a tract containing 0.99 acres which was sold to Mrs. Sarah B. McCune and also a triangular parcel of land cut from Lot 2-B containing approximately 0.54 acres which was sold to Mrs. Sarah B. McCune. Each of these parcels face the soil road which is a state-maintained road and is also known as Allgood Road, leaving a remaining acreage count of approximately 10.292 acres.

The above-described property is known on the Forsyth County Tax Maps as Lots 74B, 71F, and 72D, Block 4618.
