



ARTICLES OF INCORPORATION

OF

R & K WILSON ASSOCIATES, INC.

I, the undersigned natural person of the age of eighteen years or more, do hereby make these Articles of Incorporation for the purpose of forming a business corporation under the laws of the State of North Carolina, as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act," and the several amendments thereto, and to that end do hereby set forth:

1. NAME. The name of the corporation is R & K WILSON ASSOCIATES, INC.

2. DURATION. The period of duration of the corporation shall be perpetual.

3. PURPOSES. The purposes for which the corporation is organized are:

GENERAL. To engage in any lawful act or activity for which corporations may be organized pursuant to G.S. Chapter 55 or its successor acts; and without limitation of the foregoing, to buy, sell, trade and deal in stocks, bonds and securities of every nature, and commodities of every nature, on margin or otherwise; and in connection therewith, to borrow money and to pledge any and all stocks, bonds, securities, commodities and contracts for the future delivery thereof, to the extent permitted by G.S. Chapter 55 or its successor acts.

4. AUTHORIZED CAPITAL. The corporation shall be authorized to issue 100,000 shares of common stock with a par value of \$1.00 per share.

5. MINIMUM CONSIDERATION. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is \$100.00 in cash or other lawful consideration.

6. PREEMPTIVE RIGHTS CONFIRMED. The shareholders of the corporation shall have such preemptive rights to acquire additional or treasury shares of the corporation as are provided in G.S. 55-56, or its successor statute, and all such preemptive rights are expressly confirmed.

7. REGISTERED OFFICE AND AGENT. The address of the initial registered office of the corporation in this State is 305 First Stratford, City of Winston-Salem, County of Wake, State of North Carolina 27104-4213, and the name of the initial registered agent at such address is John A. Cocklereece, Jr.


