



ARTICLES OF INCORPORATION

OF

The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under the laws of the State of North Carolina. DATE 03/04/67 TIME16:02

The name of the corporation is R & D Industries, Inc

- The period of duration of the corporation is perpetual. FURE
- The purpose for which the corporation is organized TATE to engage in any lawful act or activity for which corporations may be organized under Chapter 55 of Hotel CAROLINA North Carolina General Statutes.
- The corporation shall have authority to issue one hundred thousand (100,000) shares with a par value of One Dollar (\$1.00) per share.
- The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is One Hundred Dollars (\$100.00) in cash or property of equivalent value.
- 6. The shareholders of the corporation shall have no preemptive right to acquire additional or treasury shares of the corporation.
