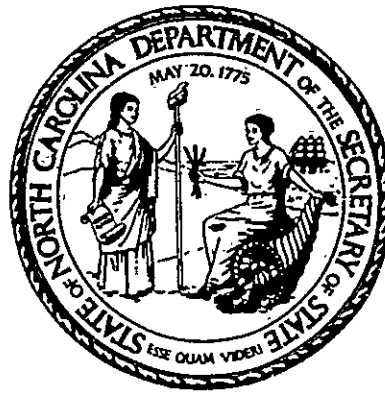

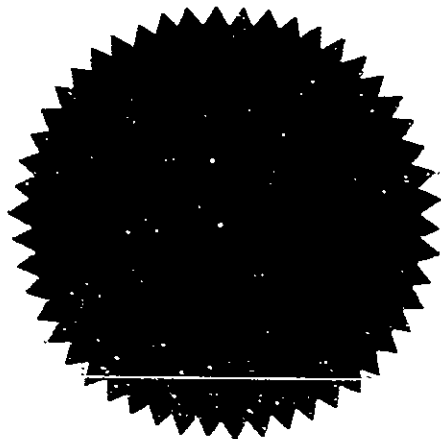

ARTICLES OF INCORPORATION  
OF  
R & D INDUSTRIES, INC.

The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under the laws of the State of North Carolina.

DATE 03/04/87 TIME 16:02

1. The name of the corporation is R & D Industries, Inc.
2. The period of duration of the corporation is perpetual.
3. The purpose for which the corporation is organized to engage in any lawful act or activity for which corporations may be organized under Chapter 55 of North Carolina General Statutes.
4. The corporation shall have authority to issue one hundred thousand (100,000) shares with a par value of One Dollar (\$1.00) per share.
5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is One Hundred Dollars (\$100.00) in cash or property of equivalent value.
6. The shareholders of the corporation shall have no preemptive right to acquire additional or treasury shares of the corporation.
7. The address of the initial registered office of the corporation in the State of North Carolina is 2271 Chipwood Lane, Winston-Salem, Forsyth County, North Carolina 27106; and the name of its original registered agent at such address is Roland H. Kaufman.
8. The number of directors constituting the initial Board of Directors shall be one (1), who shall serve as director until the first meeting of shareholders or until his successors are elected and qualify. The name of the initial director is Roland H. Kaufman, 2271 Chipwood Lane, Winston-Salem NC 27106.
9. The name and address of the incorporator is Robert Tally, 248 So. Main St., P. O. Box 10700, Winston-Salem NC 27108.
