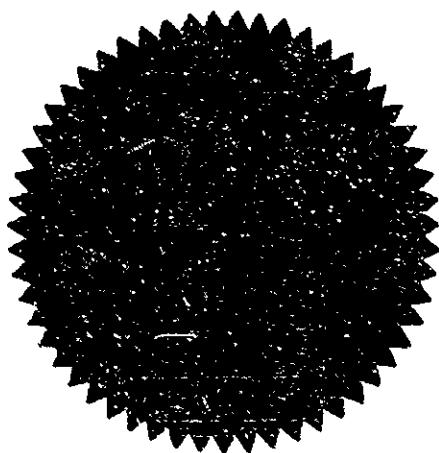

The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina;

The period of duration of the Corporation is perpetual.

III

The purposes for which the Incorporation is organized are:

- (a) To own, purchase, lease, and/or sale a truck(s) and/or tractor(s) and trailer(s) to be used in the general trucking business and/or otherwise to engage in any business relating to the trucking industry.
- (b) To operate and transact any other business authorized under the laws of the State of North Carolina.

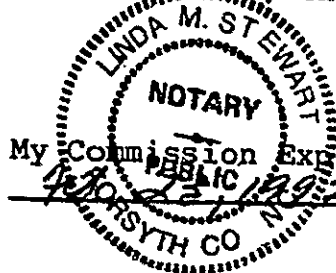
