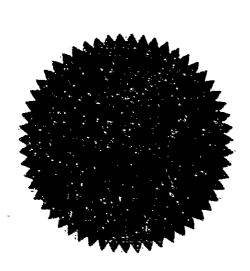

ARTICLES OF INCORPORATION

OF

S & C MANUFACTURING CO.

I, the undersigned, being a natural person of the age of eighteen years or more do hereby form a corporation under the laws of the State of North Carolina, as contained in Chapter 55 of the General Statues of North Carolina, entitled "The North Carolina Business Corporation Act," and to that end, 400 Mereby 100 158 set forth:

FILED

- 1. The name of the corporation is: S & C Manufacturing UNE
 Co.
- 2. The period of duration of this corporation shall be perpetual.
- 3. The purpose or purposes for which the corporation is organized are:
- a. To engage in the manufacturing, wholesale and distribution of goods and services of any kind whatsoever which are legal within the laws of the State of North Carolina and the United States.
- b. To engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of the State of North Carolina and the several amendments thereto.
- c. To join or consolidate with, and to enter into agreements and cooperative relations not in contravention with, any persons, firms, associations, or corporations, governmental, municipal, or otherwise, in connection with carrying out all or any of the purposes of this corporation.
- d. To conduct and carry on its business or any branch thereof in any state or territory of the United States or in any foreign country in conformity with the laws of such state, territory, or foreign country, and to have and maintain in any state, territory, or foreign country a business office, plant, store or other facility.
- e. To do all and everything necessary, suitable, or proper for the accomplishment of any of the purposes, the attainment, of any objects, or the exercise of any of the powers herein set forth, either alone or in conjunction bwith other corporations, firms, individuals, and either as incidental to or appurtenant to or growing out of or connected with the abovementioned objects, purposes, or powers.

- 4. The aggregate number of shares which the corporation shall have authority to issue is One Thousand (11,000.00) with a par value of One Dollar (\$1.00) per share.
- The preferences, limitations and relative rights in respect of the shares shall be fixed by resolution of the Board of Directors.
- 5. The minimum amount of consideration for its shares to be received by the corporation before it shall commence business is One Hundred Dollars (\$100.00).
- 6. The address of the initial registered office of the corporation is 5598 Seaward Road, Pfafftown, North Carolina 27040, and the name of the initial registered agent at such address is Bill G. Sapp.
- 7. The number of directors of the corporation may be fixed by the by-laws, but shall not be less than the number required by law.
