STATEMENT OF DEDICATION OF STREETS AND  
ROADS FOR PUBLIC USE BY A PARTNERSHIP  
(Public Streets and/or Private Drives)

We, the undersigned, do hereby state that we are the partners in S & E Associates, and that as such, we are authorized to execute this document, and that the Partnership is the owner in fee simple of the lands which we have caused to be subdivided, which lands are shown on a plat of said property, the subdivision being named Harpers Crossing, a copy of which plat is on file in the office of the City-County Planning Board of Winston-Salem and Forsyth County, and a copy of which upon final approval by the City-County Planning Board will be recorded in the office of the Register of Deeds of Forsyth County.

That the Partnership freely offers, grants, and dedicates to those who may purchase said property or any part thereof and to the general public, the use of the streets and roads shown on said plat of property for public use. That the Partnership freely offers, grants, and dedicates to those who may rent or purchase said property or any part thereof, and to their invitees or guests and to all government service vehicles and general service vehicles, such as fire, police, garbage, mail, etc. the use of the private drives as shown on said plat of property. That the Partnership shall be responsible for maintenance of the private drives as shown on said plat unless they require by recorded covenant running with the land the subsequent owners to be responsible for said maintenance.

The property shown on said plat is not encumbered by a recorded deed of trust or mortgage, or by a judgment rendered by any court, except: Deed Book 1638, Page 3442.
