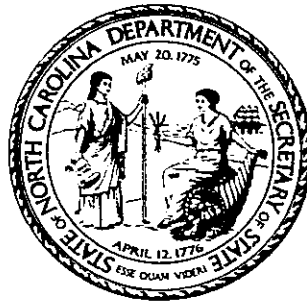

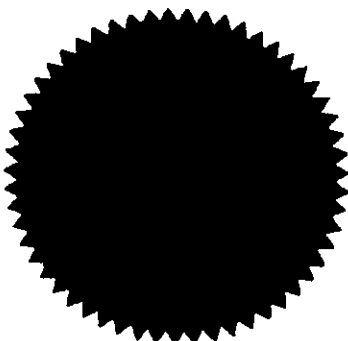

I.

The name of the corporation is A & J RENTAL, INC.

II.

THIRD CLERK

The period of duration of the corporation is perpetual.

III.

The purposes for which the corporation is organized are: leasing vehicles, and to engage in any other lawful activity including but not limited to purchasing, selling, distributions, lending, borrowing, or investing in any type of property whether real or personal, tangible or intangible; performing personal services of any nature; and entering into or serving in any type of management, advisory, promotional, insurance, guarantyship, suretyship, fiduciary or representative capacity of relationship for any persons or corporation whatsoever.

IV.

The corporation shall have authority to issue 1,000 shares with a par value of One Hundred Dollars (\$100.00) per share.

V.

The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is One Hundred Dollars (\$100.00) in cash or property of equivalent value.

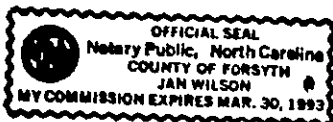
