The undersigned Corporation hereby executes these Articles of Amendment for the purpose of amending its Charter:

- 1. The name of the Corporation is W. Holbrook, Inc.
- 2. The following amendments to the Charter of the Corporation were adopted by its shareholders on the 5th day of December, 1988, in the manner prescribed by law:
 - a. The undersigned Domestic Corporation submits the following statement for the purpose of changing its registered office and its registered agent in the State of North Carolina:
 - 1. The name of the Corporation is W. Holbrook, Inc.
 - 2. The address of its present registered office is 705 Plummer Drive, Greensboro, North Carolina, 27410 (Guilford County).
 - 3. The address to which its registered office is to be changed is 531 Doud Road, Lewisville, North Carolina, 27023 (Forsyth County).
 - 4. The name of its present registered agent is M. Willisia Holbrook.
 - 5. The name of its successor registered agent is M. Willisia Hoolbrook.
 - 6. The address of its registered office and the address of the business office of its registered agent, as changed, will be identical.
 - 7. Such change was authorized by resolution duly adopted by the board of directors of the Corporation.
 - b. That the name of the Corporation be changed from W. Holbrook, Inc. to Armbrook Associates, Inc.
 - c. That Article 4 of The Articles of Incorporation of W. Holbrook, Inc. shall be amended by adding after the first sentence the language as herein set forth and all other Articles not heretofore changed shall remain unchanged by this amendment. The additional purpose or purposes for which the Corporation is organized are to purchase, or in any way acquire for investment or for sale or otherwise, lands, contracts for the purchase or sale of lands, buildings, improvements, and any other real property of any kind or any interest therein, and as the consideration for same to pay cash for other obligations of the Corporation, and to sell, convey, lease, mortgage, deed of trust, turn to account, or otherwise deal with all or any part of the real property of the Corporation; to make and obtain loans upon real estate, improved or unimproved, and upon personal property, giving or taking evidences of indebtedness and securing the payment thereof by mortgage, deed of trust, pledge or otherwise: and to enter into contracts to buy or sell or improve any real property, real or personal: to purchase or otherwise acquire for the purpose of holding or disposing of the same, real or personal property of every kind and description, paying for the same in cash, stock, or bonds of this Corporation: and to draw, make, accept, endorse, discount, execute, and issue promissory notes, bills of exchange, warrants, debentures, and other negotiable the or obligations of transferrable instruments, Corporation from time to time, for any of the objects or purposes of the Corporation without restriction or limit as to amount: and to render, provide, assist or otherwise make improvements upon real estate whether owned by the Corporation or others and whether upon existing structures or vacant property and to have the rights, powers and privileges pursuant thereto and in furtherance thereof.
