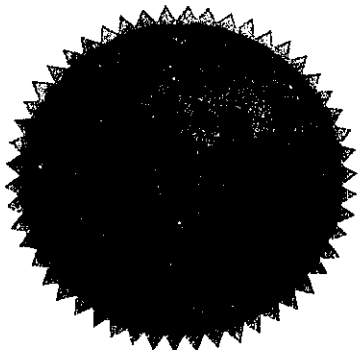

The undersigned, being of the age of eighteen (18) ~~NORTH CAROLINA~~ or more, do hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of North Carolina.

1. The name of the corporation is J & A Consultant Services, Inc.;
2. The period of duration of the corporation is perpetual;
3. The purposes for which this corporation is organized are:
 - (a) To act as consultant, teacher, sales representative in beauty care, aids, supplies and products primarily for but not limited to individual clients; to promote, demonstrate and sell individual items or other household products and office supplies primarily but not limited to beauty care;
 - (b) To engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the North Carolina General Statutes;
4. The corporation shall have the authority to issue One Hundred Thousand (100,000) shares of stock with no par value;
5. The minimum amount of consideration to be received for its shares and for which the corporation shall commence business is Five Hundred (\$500.00) Dollars;

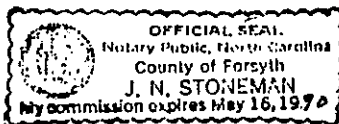
