EXHIBIT "A"

BEGINNING at an iron stake in the north line of South Stratford Road, Silas Creek Parkway ramp, running thence with the North right-of-way of said ramp; South 87 degrees 27 minutes West 153.18 feet to an iron stake, thence North 89 degrees 16 minutes West 20.10 feet to an iron stake, a new corner; running thence on a new line, North 06 degrees 21 minutes East 247.55 feet to an iron stake in the south line of a new street; to be called Charlois Boulevard; thence with the south line of said street, South 83 degrees 32 minutes East 193.97 feet to an iron stake; thence on a curve to the right which has a radius of 23 feet and an arc distance of 34.93 feet and having a chord direction and distance of South 40 degrees 1.5 minutes East 31.67 feet to an iron stake in the west line of a new street to be named Mall Boulevard; thence with said line, South 3 degrees 29 minutes West 117.46 feet to an iron stake; thence North 86 degrees 32 minutes West 12.96 feet to an iron stake, the point and place of beginning. Containing 1.113 acres, and being a portion of the P.H. Hanes Knitting Company Property conveyed to Hanes Properties, Inc., lying on the north side of South Stratford Road-Silas Creek Parkway ramp.
