ARTICLES OF INCORPORATION OF B & A INSURANCE INVESTMENTS, INC.

- I, the undersigned, a natural person of the age_stghreen? INF16:55 (18) year or more, do make and acknowledge these Articles Articles After Incorporation for the purpose of forming a business corporation After under and by virtue of the laws of the State of North Carolina, OF STATE entitled "BUSINESS CORPORATION ACT," and to that end do hereby set ARULINA forth:
- 1. The name of the Corporation is B & A Insurance Investments, Inc.
- 2. The period of duration of the Corporation shall be perpetual.
- 3. The purpose or purposes for which the Corporation is organized are:
 - (a) To provide consulting services in the field of insurance.
 - (b) To purchase or acquire by merger or other business combination any business, goodwill and other property of any individual, corporation or other entity, whether as a going concern or otherwise, and to assume any or all of its debts, contracts and obligations; to buy or acquire by merger or other business combination securities, goods, merchandise in bulk and any and all other property, whether real, personal or mixed and whether located within or without the State of North Carolina; and also to sell or otherwise dispose of any of the foregoing property.
 - (c) To engage in any lawful act or activity for which a corporation may be organized under the BUSINESS CORPORATION ACT.
- 4. The aggregate number of share which the Corporation shall have authority to issue is One Hundred Thousand (100,000) shares of Common Stock of one class of the par value of One Dollar (\$1.00) per share. Each outstanding share of Common Stock shall entitle the holder to one vote on each matter as to which said holder is entitled to vote under the BUSINESS CORPORATION ACT. No shares shall be entitled to be voted cumulatively except only in the event and to the extent that cumulative voting is specifically required by the BUSINESS CORPORATION ACT.

- 5. The minimum amount of consideration to be received for its shares and for which the Corporation shall commence business is One Hundred Dollars (\$100.00).
- 6. The address of the initial registered office of the Corporation is 5107 Williamsburg Road, Winston-Salem, North Carolina, in the County of Forsyth, State of North Carolina, and the name of the initial registered agent at such address is James L. Allen.
- 7. The number of Directors of the Corporation may be fixed by the By-Laws but shall not be less than three (3), except as permitted by North Carolina General Statutes Sec. 55-25. The number of Directors constituting the initial Board of Directors shall be three (3) and the names and addresses of the individuals who will serve as the initial Directors until the first meeting of Shareholders, and until their successors are elected and qualified are:

- 9. No shareholder or class of shareholders shall have any preemptive or related right to acquire additional or treasury shares of the Corporation or any options, right or warrants for such shares, which may at any time be authorized, granted, issued, sold or offered for sale by the Corporation.
- 10. To the fullest extent permitted by North Carolina General Statutes Section 55-19 and all other applicable provisions of the BUSINESS CORPORATION ACT, as the same now exists or may hereafter be amended, the Corporation shall indemnify all persons serving as officers or directors of the Corporation, or in both such capacities, against all liability and litigation expense, including but not limited to reasonable attorneys' fees, arising out of their status as such or their activities in any of the foregoing capacities, regardless of when such status existed or activity occurred and regardless of whether or not they are

officers or directors of the Corporation to the time such indemnification is sought or obtained. In addition to the foregoing indemnity, such persons may also recover from the Corporation all reasonable costs, expenses, and attorneys' fees in connection with the enforcement of rights to indemnification granted by this Paragraph 10. The provisions of this Paragraph 10 are in addition to and not in limitation of the power of the Corporation with respect to, and the rights of any officer, director, employee or agent of the Corporation to receive the benefits of, any other or further indemnification, insurance, elimination of liability or other right or benefit which is either required by the BUSINESS CORPORATION ACT or permitted thereby and duly adopted by the Corporation in accordance therewith.
