

ARTICLES OF INCORPORATION

OF

S & L BUILDINGS, INC.

I, the undersigned, being the age of Eighteen (18)
years or more, do hereby form a business under the Laws of North
Carolina, as contained in Chapter 55 of the General Statutes of UNEXT #471170
North Carolina, entitled "Business Corporation Act", and the FILED
several amendments thereto, and to that end do hereby set for INTISTEN

The name of the corporation is S & L BUILDINGS, INC.

II

The period of duration of the corporation shall be perpetual.

III

The purposes for which the corporation is organized are:

- A. To distribute and be an exclusive distributor for the promotion, marketing, and sale of certain rotatable storage and utility buildings for the State of North Carolina, together with all related transactions and business associated therewith.
- B. Directly, or through ownership of shares of any corporation, to purchase or otherwise acquire, hold, manufacture, develop, sell, exchange, mortgage, create a security interest in, pledge, hypothecate, deal in and dispose of land, commodities, building materials, and other personal and real property of every kind and interest therein.
- C. To enter into, make and perform a contract and services of every kind and description, with any person, firm, association, corporation, municipality, county, state, body politic, or government or dependency thereof.
- D. To engage in any lawful act or activity for which corporations may be organized under the Business Corporation Act and the several amendments thereto for the State of North Carolina.

IV

The aggregate number of shares which the corporation shall have authority to issue is One Hundred Thousand (100,000) with a par value of One (\$1.00) Dollar per share.

The minimum amount of consideration for its shares to be received by the corporation before it shall commence business is Five Hundred Dollars (\$500.00).

VI

The address of the initial registered office of the corporation is 485 Essen Place, Kernersville, Forsyth County, North Carolina, and the name of the initial registered agent is JOHN RAY LIDDLE.
