MEMORANDUM OF LEASE

Located in Winston Township, Forsyth County, North Carolina, Beginning at an iron in the north right-of-way line of Old Vineyard Road at the southeast corner of Lot 40, Burke Park, the Asa W. Inabinet property and being the southwest corner of Lot 41, hereinafter referred to, thence with Lots 40 and 47 North 31° 08' 15" East 253.40 feet to an iron; thence south 52° 44' East 122.21 feet to a concrete monument; thence south 06° 12' East 75.09 feet to a concrete monument in the right-of-way line of N.C. Highway #158; thence with the right-of-way line of N.C. Highway #158 south 37° 10' West 103.80 feet to a concrete monument; thence with the right-of-way line of Old Vineyard Road North 80° 15' West 174.31 feet to an iron in the place of BEGINNING; being the greater parts of Lots 41, 42, 43, 44, 45 and 46, Burke Park Development, Plat Book 12, Page 20; as surveyed by John G. 
