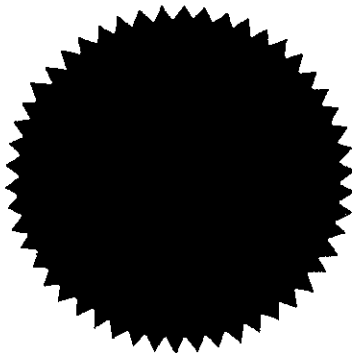

The undersigned, being of the age of eighteen years or more, do hereby make and acknowledge these Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the State of North Carolina.

1. The name of the corporation is V & M TRUCKING COMPANY.
2. The period of its duration is perpetual.
3. The purpose of the corporation is:
 - a. To haul all types of goods and freight by truck.
 - b. To employ others to haul all types of goods and freight.
 - b. To engage in any lawful act or activity for which corporations may be organized under the North Carolina Business Corporation Act.
4. The corporation shall have the authority to issue Ten Thousand shares of stock, all of one class, with a par value of Ten Dollars.
5. The minimum amount of consideration to be received by the corporation for its shares before it shall commence business is ONE THOUSAND DOLLARS (\$1,000.00)
6. The address of the initial registered office of the Corporation is 2363 West Clemmons ville Road, Winston-Salem, (Forsyth County) North Carolina 27127. The name of the initial registered agent of the corporation is VICKIE HOLDER HAGA.

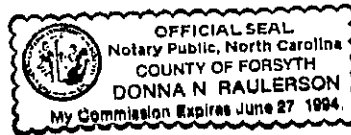
