(hereinafter called "Original Borrowers", whether one or more persons, corporations, or firms) as evidenced by Notes dated the 10th day of July , 1986, in the principal amount of 5,000.00 the terms and conditions of which are incorporated herein by reference thereto, and as security for the payment of the Notes, the Original Borrowers executed and delivered to Lender Deeds of Trust of even date therewith conveying certain real property, recorded in Book 1553, page 1824, Forsyth County Registry, the terms and conditions of which are incorporated herein by reference; and the Original Borrowers and/or their successors in title desire (i) to sell the property described in the Deeds of Trust to the Borrowers, (ii) to have the Borrowers assume and agree to pay the Notes in the place and stead of the Original Borrowers or their successors in title, and (iii) to have the Lender release them from their obligation under the said Notes and Deeds of Trust; and
