WITNESSETH, that the Grantor, for a valuable consideration paid by the Grantee, the receipt of which is hereby acknowledged, has and by these presents does grant, bargain, sell and convey unto the Grantee in fee simple, all that Bethania . Township, certain lot or parcel of land situated in the City of

County, North Carolina and more particularly described as follows: Forsyth

Beginning at an iron stake located in the east right-of-way line of Moore-RJR Road, said point being the southwest corner of Flossie A. Moore (Deed Book 469 Page 287), said point also being the northwest corner of M & D Investments (Book 1688 Page 2483); thence from said Beginning point with the east right-of-way line of Moore-RJR Road north 32 degrees 13 minutes 07 seconds east 18.13 feet to a point; thence south 85 degrees 28 minutes east 227.28 feet to a point in the west line of Nancy D. Gunnell (now or formerly); thence with the west line of Gunnell south 10 degrees 52 minutes 13 seconds west 16.15 feet to an iron stake; thence with the north line of M & D Investments north 85 degrees 28 minutes 00 seconds west passing through an iron stake at 63.87 feet and continuing 170.05 feet for a total distance of 233.92 feet to the Beginning, and being a portion of the property described in Deed Book 469 Page 287 Forsyth County Registry.
