## STATEMENT OF DEDICATION OF STREETS AND ROADS FOR PUBLIC USE

FORSYTH COUNTY, NORTH CAROLINA

THIS INSTRUMENT made this 24th day of July, 1991.

The designation Grantor as used herein shall include said parties, their heirs, successors, and assigns, and shall include singular, plural, masculine or feminine as required by context.

The undersigned Grantor does hereby state that he is the owner in fee simple of the lands which he has caused to be subdivided, which lands are shown on a plat of said property, the subdivision being named Mystic Glen, a copy of which plat is on file in the office of the City-County Planning Board of Winston-Salem and Forsyth County, and a copy of which, upon final approval by the City-County Planning Board, will be recorded in the office of The Register of Deeds of Forsyth County.

The Grantor freely offers, grants and dedicates to those who may purchase said property or any part thereof and to the general public, the use of the streets and roads shown on said plat of property for public use. The Grantor freely offers, grants and dedicates to those who may rent or purchase said property or any part thereof, and to their invitees or guests and to all governmental service vehicles, such as fire, police, garbage, mail, etc. the use of the private drives as shown on said plat of property. The Grantor shall be responsible for maintenance of the private drives as shown on said plat unless the Grantor requires by recorded covenant running with the land the subsequent owners to be responsible for said maintenance.

The property shown on said plat is not encumbered by a recorded deed of trust or mortgage, or by a judgment rendered by any court, except none.
