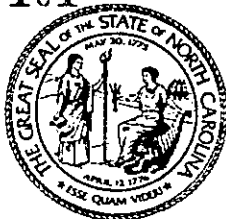

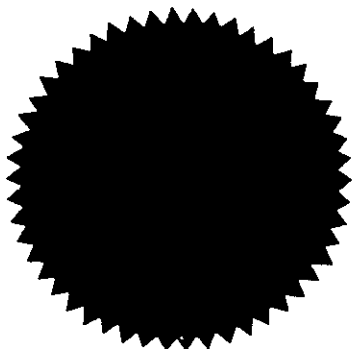

## ARTICLES OF INCORPORATION

The undersigned natural person of the age of eighteen years or more, does hereby establish a business corporation under the laws of the State of North Carolina as contained in Chapter 55 of the General Statutes of North Carolina, entitled "Business Corporation Act," and the several amendments thereto, and to that end does hereby set forth:


1. The name of the Corporation is C & C SANDBLASTING, INC.
2. The period of duration of the Corporation shall be perpetual.
3. The purpose for which the Corporation is organized is to engage in any lawful act or activity for which corporations may be organized under Chapter 55 of the General Statutes of North Carolina.
4. The aggregate number of shares which the Corporation shall have authority to issue is 100,000 all of one class having a par value of \$1.00 per share.
5. The minimum amount of consideration for its shares to be received by the Corporation before it shall commence business is \$1.00 in cash or property of equivalent value.
6. The address of the initial registered office of the Corporation is 408 Dewey Street, Kernersville, Forsyth County, North Carolina, 27284, and the name of the initial registered agent at such address is Susan B. Cantrell.
7. To the fullest extent permitted by the North Carolina Business Corporation Act as it exists or may hereafter be amended, no person who is serving or who has served as a Director of the Corporation shall be personally liable to the Corporation or any of its Shareholders for monetary damages for breach of duty as a Director. No amendment or repeal of this Article, nor the adoption of any provision to these Articles of Incorporation inconsistent with this Article, shall eliminate or reduce the protection granted herein with respect to any matter that occurred to such amendment, repeal, or adoption.
8. In addition to the general powers granted Corporations under the laws of the State of North Carolina, the Corporation shall have full power and authority to do and perform all acts not specifically prohibited by law and which could be performed if

recited verbatim in this Charter.
