SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT entered into this lst day of December , 19 92 , by ROBERT W. PORTER

["Trustee") and NationsBank of North Carolina, N.A. (formerly North Carolina National Bank and NCNB National Bank of North Carolina) a national banking association, ("NationsBank") in favor of NATIONSBANC MORTGAGE CORPORATION the ("Lender").

AND WHEREAS, Owner has requested that NationsBank and Trustee subordinate the NationsBank Deed of Trust to the lien of that certain deed of trust dated the 23 day of October, 19 92, to as trustee for the benefit of Lender, recorded in the Forsyth County Public Registry in Book 1761, at Page 390 and securing a loan in the original amount of \$.525,000.00 (the "Lender's Deed of Trust");

NOW: THEREFORE, for valuable consideration, and subject to the terms of this Subordination Agreement, NationsBank and Trustee do hereby subordinate the lien of the NationsBank Deed of Trust to the lien of the Lender's Deed of Trust. Trustee and NationsBank do hereby reserve all rights, title and interest under the NationsBank Deed of Trust except as subordinated by this Subordination Agreement.

This Agreement only subordinates the NationsBank Deed of Trust to the Lender's Deed of Trust to the extent of the original amount of \$99,000.00 and any amounts advanced pursuant to the provisions of the Lender's Deed of Trust for payment of Insurance premiums, taxes, cost of collection, or protection of the value of the above described property or Lender's rights in said property. This Agreement is not a subordination of the lien of the NationsBank Deed of Trust to any renewals, future advances, modifications, or rearrangements of the Lender's Note or Deed of Trust.

This Agreement contains the whole agreement between the parties hereto: as to the subordination of the lien of the NationsBank Deed of Trust to the lien of the Lender's Deed of Trust, and the priority thereof. There are no agreements, written or oral, outside or separate from this Agreement and all prior negotiations, if any, are merged into this Agreement.
