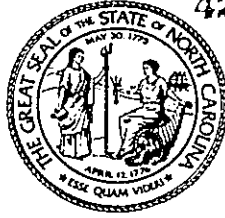

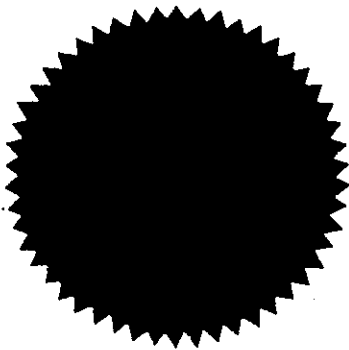


ARTICLES OF INCORPORATION
