MODIFICATION OF RESTRICTIVE  
COVENANTS FOR LOT 37,  
PEACE HAVEN ESTATES

WHEREAS, W. BRYAN WHITE REALTY COMPANY caused the Declaration of Restrictive Covenants for Peace Haven Estates to be recorded in Deed Book 815, Page 496, on November 28, 1960, in the Office of the Register of Deeds of Forsyth County, North Carolina, which Restrictive Covenants applied to all lots in Peace Haven Estates, as originally recorded in Plat Book 20, Page 82(2), Forsyth County Registry; and

THAT, WHEREAS, W. BRYAN WHITE REALTY COMPANY, the Declarant in said Declaration, hereinafter referred to as "Declarant", retained a right of modification of said Restrictive Covenants in Article 13, reserving the right to remove, modify or change any of the referenced restrictions; and

THAT, WHEREAS, W. BRYAN WHITE REALTY COMPANY, was dissolved on October 18, 1988, said Dissolution being recorded in Deed Book 1653, Page 3952, Forsyth County Registry, and attached to said Dissolution is a written consent by the shareholders of W. BRYAN WHITE REALTY COMPANY, indicating that DOROTHY W. DURHAM (formerly Dorothy White) was the sole shareholder as of the date of dissolution; and

THAT, WHEREAS, DOROTHY W. DURHAM (FORMERLY DOROTHY WHITE), now stands in the place and stead of W. BRYAN WHITE REALTY COMPANY as the Declarant and does hereby desire to modify said Restrictive Covenants, with respect to Lot 37, Peace Haven Estates, Plat Book 20, Page 82(2), Forsyth County Registry, as follows:

1. Article 5 is hereby deleted in its entirety, and the following is substituted in its place and stead:

(5) "No single family dwelling shall be used or built, altered or erected to be used unless the main body of the structure on its ground or main floor, exclusive of porches and terraces, contains 1420 or more square feet of floor space as measured to the outside wall lines."

2. The remainder of said Restrictive Covenants are hereby restated by reference as if fully set forth herein.
