MODIFICATION OF NOTE AND DEED OF TRUST ("Modification")

WHEREAS, Beneficiaries/Noteholders, by instrument of even date herewith, have substituted the Substitute Trustee as Trustee under the Deed of Trust; and

WHEREAS, the Grantor/Borrower and the Beneficiaries/Noteholders have agreed to a modification of the current principal balance and payment terms of the Note to reflect an additional advance in the amount of \$40,000 and to reflect the transfer by Ann C. Phillips of her interest in the Note to Charles K. Phillips, and are desirous of documenting that modification and recording public notice of said change;

NOW THEREFORE, the Grantor/Borrower and the Beneficiaries/Noteholders, do hereby modify the Note and the Deed of Trust to provide that Charles K. 
