
WHEREAS, the City Council after a separate public hearing finds that the property described herein is of historical, architectural, and/or cultural significance, and the property's preservation should be encouraged, and that the qualifying elements exist as set forth in the Historic Resources Commission report:

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Winston-Salem as follows:

The following described property is hereby designated a historic landmark: Section 1. Charles A. Cooper House, 411 South Main Street, specifically: the complete exterior of the Charles A. Cooper House Building; the complete archaeological site comprising the original brickyard; all archaeological, landscape, and site features and components on the grounds; and, all of Tax Block 0558, Tax Lots 118B and 119 (PIN #6835-24-9263.00). This property is owned by Steven and Patricia Cole.

The review process provided by law shall be observed prior to demolition, Section 2. alteration, rehabilitation, or removal of the designated property.

This ordinance shall be effective from and after its adoption. Section 3.


