The undersigned Affiant being first duly sworn, hereby swears or affirms that the ORDINANCE DESIGNATING CERTAIN PROPERTY AS A HISTORIC LANDMARK recorded on May 28, 2019 in Book 3462, Page 2054, Forsyth County Registry, by the Forsyth County Historic Resources Commission contained the following *typographical or other minor error*:

The names of the owners of the property at the time of Local Historic Landmark designation were not included in the Ordinance.

Affiant makes this Affidavit for the purpose of correcting the above-described instrument as follows:

The Forsyth County Historic Resources Commission recommended that the Philip and Johana (Hoehns) Hanes House be designated as a historic property. 

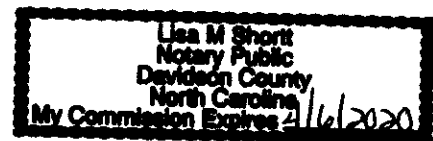

**ORDINANCE DESIGNATING CERTAIN PROPERTY
 AS A HISTORIC LANDMARK**

Ordinance Number 2015-08

WHEREAS, all of the prerequisites to the adoption of this ordinance as prescribed by Chapter 160A, Article 19, Part 3C of the North Carolina General Statutes have been met; and

WHEREAS, the Forsyth County Historic Resources Commission has submitted a report, which is incorporated herein by reference, and recommends after a separate public hearing that the property described below be designated a historic landmark; and

WHEREAS, the Clemmons Village Council after a separate public hearing finds that the property described herein is of historical, architectural, and/or cultural significance, and the property's preservation should be encouraged, and that the qualifying elements exist as set forth in the Historic Resources Commission report:


NOW, THEREFORE, BE IT ORDAINED by the Mayor and Village Council of the Clemmons, NC as follows:

Section 1. The following described property is hereby designated a historic landmark: Philip and Johanna Hoehns (Hanes) House, 3550 Middlebrook Drive, Clemmons, NC, specifically: the complete exterior and interior of the Philip and Johana (Hoehns) Hanes House and the tax block and lot upon which it sits (Tax Block 4208, Lot 036B and 040H/PIN #5892-027883.00).

Section 2. The review process provided by law shall be observed prior to demolition, alteration, rehabilitation, or removal of the designated property.

Section 3. This ordinance shall be effective from and after its adoption.

Adopted this the 9th day of November, 2015.
