## CERTIFICATE OF INCORPORATION

OF

This is to certify that we, the undersigned, do hereby associate ourselves into a corporation under and by virtue of the laws of the State of North Carolina for such purpose made and provided, and do severally agree to take the number of shares of capital stock in said corporation set opposite our respective names; and to that end do hereby execute this certificate of incorporation in manner and form as follows:

1.

The name of this corporation is M and K Construction Company.

2.

The location of the principal office of the corporation is in the City of Elkin, Surry County, in the State of North Carolina, but it may have one or more branch offices and places of business either in the State of North Carolina or in any other State.

3.

The objects for which this corporation is formed are:

(a) To construct and build houses and other buildings of every sort and kind, and to purchase real estate and personal property and to sell same at public auction or otherwise; to take and secure options on all kinds of property for the purpose of sale, and to charge commissions on said property for selling same, and to engage in a general real estate and construction business.

(b) To engage in, conduct and operate any other business which may be deemed adapted, directly or indirectly, to add to the profits of its principal business or to increase the value of its property.
