THIS DEED, made this 1st day of January, 1971,
by THRIFT COURTS, INC., a corporation of Perry, Houston County,
Georgia, party of the first part, to O & A, INC., a corporation
of Winston-Salem, Forsyth County, North Carolina, party of the
second part,

W I T N E S S E T H :

THAT said party of the first part in consideration of
Ten Dollars and other valuable considerations (\$10.00 & o.v.c.)
to it paid by party of the second part, receipt of which is hereby
acknowledged, has bargained and sold and by these presents does
bargain, sell and convey to said party of the second part and
its successors, heirs and assigns, a certain tract or parcel of
land and all improvements thereon in Middlefork Township, Forsyth
County, North Carolina, bounded as follows:


Lying and being in Middlefork No. 1 Township
and BEGINNING at an iron stake in the eastern
right-of-way line of U. S. Highway 52, the
same being south 28 deg. 30 mins. east 194.83
feet from the southeast intersection of North
Carolina Highway 8 and U. S. Highway 52, and
running thence North 88 deg. 12 mins. East
411.43 feet to an iron stake; thence North
07 deg. 41 mins. East 249.25 feet to an iron
stake; thence South 76 deg. 06 mins. 40 sec.
East 666.64 feet to an iron stake; thence
South 04 deg. 04 mins. 10 sec. West 643.57 feet
to an iron stake; thence South 89 deg. 42
mins. West 523.00 feet to an iron stake;
thence North 28 deg. 30 mins. West 360.00
feet to an iron stake; thence South 61 deg.
30 mins. West 199.75 feet to an iron stake
in the eastern right-of-way line of U. S.
Highway 52; thence with the eastern right-
of-way line of U. S. Highway 52, North 28
deg. 30 mins. West 368.25 feet to an iron
stake, the point and place of BEGINNING,
same containing 12.88 acres, more or less,
and being that same property described in
